Jacquelyn C. Campbell, PhD, RN, FAAN



Dr. Jacquelyn C. Campbell is the Anna D. Wolf Endowed Chair and a Professor in the Johns Hopkins University School of Nursing with a joint appointment in the Bloomberg School of Public Health as well as the National Program Director of the Robert Wood Johnson Foundation Nurse Faculty Scholars Program.

Her BSN, MSN and PhD are from Duke University, Wright State University and the University of Rochester Schools of Nursing.

She has been conducting advocacy policy work and research in the area of domestic violence since 1980. Dr. Campbell has been the PI of 12 major NIH, NIJ or CDC research grants and published more than 220 articles and seven books on this subject, including the textbook *Family Violence and Nursing Practice* with Janice Humphreys. She has been working on research & policy initiatives on the intersection of HIV & GBV since 2000, including a meeting of the IOM Forum on Global Violence Prevention specifically addressing the intersection in 2014.

Dr. Campbell has received numerous awards including elected membership in the Institute of Medicine and the American Academy of Nursing, three honorary doctorates, the Pathfinder Award from FNINR, and is Co-Chair of the IOM Forum on Global Violence Prevention. Dr. Campbell proudly is a member of the Board of Directors of Futures Without Violence, was a member of the congressionally appointed US Department of Defense Task Force on Domestic Violence, and has been a board member at 3 shelters.

Participants will:

- Participants will be provided an in-depth description of the lethality assessment process related to domestic violence, to include how to effectively employ the assessment to affect the response of systems to both the victim and perpetrator of the violence.
- Participants will be given an understanding of the fatality review process, including those who should participate to ensure it is effective and how the process should lead to specific systemic changes that can be made to decrease the likelihood of future fatalities.
- As a result of the discussion regarding lethality assessments and the fatality review process, attendees will develop a better understanding of the barriers that exist for victims in accessing resources, and begin to associate this understanding with the need to arrange services accordingly, victims and survivors, and systems in general as a means to identify and alleviate gaps that exist within those structures.
